Small businesses represent 99.9 percent of all United States businesses and employ 47.1 percent of the U.S. workforce. Small and mid-sized enterprises ("SMEs") are the lifeblood of the U.S. economy, driving business development, economic vitality, and human progress. Many of our SMEs, including start-ups, entrepreneurs, independent creators, and inventors, have developed a brand and taken it to market – creating a product or service that directly benefits consumers, improving and enriching their lives. These ideas often form the basis of enforceable intellectual property rights. When these rights are exploited, everyone loses.

This webinar will help you understand how CBP can help you protect your trademarks and copyrights

The CBP Office of Trade is not only tasked with facilitating legitimate trade, but also enforcing the law, safeguarding the American economy, ensuring consumer safety, and creating a level playing field for American businesses -- especially our SMEs! CBP has broad authority to protect federally registered trademarks and copyrights at the border by preventing the entry of infringing imports into U.S. commerce, provided these IP rights are recorded through the e-Recordation program (visit <https://iprr.cbp.gov/> for more information). CBP enforces all recordations, no matter how large or how small the enterprise of the IP owner.

There are many advantages and benefits for SMEs that choose to protect their IP with CBP, and the Office of Trade is here to help! Tune in to the webinar to hear from IP law and policy experts about CBP programs available to IP owners. Topics include the following:
